

Rocking Chair Studio Privacy Policy

Rocking Chair Studio takes your privacy seriously. Please read the following to learn more about our privacy policy.

What This Privacy Policy Covers

- This policy covers how Rocking Chair Studio treats personal information that Rocking Chair Studio receives and collects, including information related to your past use of Rocking Chair Studio web sites. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.
- This policy does not apply to the practices of companies that Rocking Chair Studio does not own or control, or to people that Rocking Chair Studio does not employ or manage.

Information Collection and Use

General

- Rocking Chair Studio collects personal information when you register with Rocking Chair Studio and when you visit Rocking Chair Studio pages.
- When you register we ask for information such as your name, your address, email address, and zip code. Once you register with Rocking Chair Studio and sign in to our services, you are not anonymous to us.
- Rocking Chair Studio may collect information about your transactions with us.
- Rocking Chair Studio automatically receives and records that information on our server logs from your browser, including your IP address, Rocking Chair Studio cookie information, and the page you request.
- Rocking Chair Studio uses information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products, catalogs and services, improve our services or to contact you.

Children

- Rocking Chair Studio does not ask a child under age 13 for more personal information, as a condition of participation, than is reasonably necessary to participate in a given activity.
- Rocking Chair Studio does not post content unfit for children at any time.

Information Sharing and Disclosure

- Rocking Chair Studio does not rent, sell, or share personal information about you with other people or companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:
 - We provide the information to trusted partners who work on behalf of or with Rocking Chair Studio under confidentiality agreements. These companies may use your personal information to help Rocking Chair Studio communicate with you about offers from Rocking Chair Studio and our marketing partners. However, these companies do not have any independent right to share this information.
 - We have a parent's permission to share the information if the user is a child under age 13. Parents have the option of allowing Rocking Chair Studio to collect and use their child's information without consenting to Rocking Chair Studio sharing of this information with people and companies who may use this information for their own purposes;
 - We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims;
 - We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Rocking Chair Studio's terms of use, or as otherwise required by law.
 - We transfer information about you if Rocking Chair Studio is acquired by or merged with another company. In this event, Rocking Chair Studio will notify you before information about you is transferred and becomes subject to a different privacy policy.

Cookies

- Rocking Chair Studio may set and access Rocking Chair Studio cookies on your computer.
- Rocking Chair Studio does not use web beacons to track users. Web beacons are small images placed on a page by a third party vendor to track your progress on web sites. Rocking Chair Studio does not condone or subscribe to these services.

Your Ability to Edit and Delete Your Account Information and Preferences

General

- You can edit your Rocking Chair Studio Account Information, including your marketing preferences, at any time.
- New categories of marketing communications may be added to the Marketing Preferences page from time to time. Users who visit this page can opt out of receiving future marketing communications from these new categories or they can unsubscribe by following instructions contained in the messages they receive.
- We reserve the right to send you certain communications relating to the Rocking Chair Studio service, such as service announcements, administrative messages and the Rocking Chair Studio Newsletter, that are considered part of your Rocking Chair Studio account, without offering you the opportunity to opt-out of receiving them.
- You can delete your Rocking Chair Studio account by sending an email to security@rockingchairstudio.com with the subject "Remove". If you enter "Remove Permanently", you will be added to a list that can not sign up again and will not receive further communication from Rocking chair Studio except to confirm permanent deletion. Information that was previously entered will remain in our archived records even after your account has been deleted.

Children

- Parents can review, edit, and delete information relating to their child's Rocking Chair Studio account using tools offered by Rocking Chair Studio.
- If a parent chooses not to allow us to further collect or use a child's information, parents enrolled in Rocking Chair Studio can delete their child's account by sending an email to security@rockingchairstudio.com with the subject "Remove". If you enter "Remove Permanently", you will be added to a list that can not sign up again and will not receive further communication from Rocking chair Studio except to confirm permanent deletion. Information that was previously entered will remain in our archived records even after your account has been deleted.

Confidentiality and Security

- We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.
- We have physical, electronic, and procedural safeguards that comply with federal regulations to protect personal information about you.

Changes to this Privacy Policy

- Rocking Chair Studio may update this policy. We will notify you about significant changes in the way that we treat personal information by sending a notice to the primary email address specified in your Rocking Chair Studio account or by placing a prominent notice on our site.
